

## WEBSITE TERMS OF USE

These terms of use (together with the documents referred to in it) ("**Terms of Use**") are the terms on which you may access and use our website [www.gileadliver.co.uk](http://www.gileadliver.co.uk) (our, or this "**Website**"). Please read these Terms of Use carefully before using our Website.

By accessing or using our Website, you confirm that you accept these Terms of Use, you agree to comply with them, and you represent that you are at least eighteen (18) years of age. If you do not agree to these Terms of Use, you must not access or use our Website.

This Website is operated by Gilead Sciences Ltd ("**Gilead**", "**we**", "**us**", "**our**"). which is a company incorporated and registered in England and Wales under company number 02543818 and whose registered office is at 280 High Holborn, London, WC1V 7EE. ### 1 Agreement to Terms of Use
